

The references are at times a bit confusing. Since many of my sources are abstracts of the original records, there is a page in the book of abstracts as well as a page for the original record. If the page number stands alone, it is the page number of the book cited. If I include the page number from the original record, it is within brackets: [ ].

In giving the reference, my main purpose is to identify as simply and yet as clearly as I can the source from which it came. In parentheses after the incident, I give first the author of the work and lastly the page on which the fact is found. Often the author is responsible for more than a single work. When this is the case, the second part of the parenthetical reference is descriptive in such a way that it should help the reader find the work I am talking about. It may include a phrase or two from the title or a volume number etc.

If an entry has multiple references, I may have got information from one which the other did not have. For that reason, it may be necessary to check both. I also occasionally reference microfilm numbers. These are the numbers used by the Family History Library in Salt Lake. If a reference is followed by "sr" it refers to the fact that that entry is also included in the chronology compiled in the book "The Santa Rosa Mashburn's."

Note also that for deeds, if a Mashburn is involved in the actual sale, I take the date of the transaction. If a Mashburn is a witness, I take the date of probate.

and White Oak. (Cain, vol 7, 225; Saunders, vol 3, 256)sr

- 1731 11. 9 In Bertie Co., "a power of Attry from Edwd. Marshburn to Francis Parker and Jethro Marshburn was proved in Open Court by the Oath of Patrick Ogwin which is ord. to be Recorderd. Mr. Parker to pay 16/." (Haun, Bertie, 20 [Bk 1 p 33])
- 1733 5. 8 Edward Mashborn sells land in Bertie to Hugh Horton. Proven by Jethro Mashborn. (NOTE: It is interesting that there are no Mashborn's in subsequent volumes of this reference in Bertie after this date.) (Haun, Bertie, 41 [Bk 1 p 85])
- 1734 3. 23 Edward Marshborne made justice of the peace in Onslow. (Cain, vol 8, 23; Saunders, vol 4, 46)
- 1735 2. 20 Edward Marshburn .receives 640 acres in Onslow Precinct "on ye south side of New River, joining a Branch." (Cain, vol 8, 54; Hofmann, vol 1 1982, [Bk3 #1449 p304]) sr
- 1737 2. 16 Daniel Mashburn receives 300 acres in Onslow. (Hofmann, vol 1 1982, [Bk5 #3016 p263])
- 1737 6. 8 An inventory on the estate in Bertie of Francis Parker by Edwd Buxton dated May 11 1737. The account of sale, June 8 1737 by Edwd Buxton lists Buyers - the widow Parker, George Downing, John Battle, Ben Rawlins, William Kinchen, William Knight, Daniel Marshburn, Hugh Horton and Edward Buxton. - 1739 Feb Matthew Mashborne witness to a land transaction in Bertie between Thomas Ward and Thomas Futerill Mar 8 1739. (Bell, vol 4, 218 [F52])

- 1741 Feb In Bertie, Jan 19 1740, a power of attorney is given by Nathaniel Keele to Matthew Whitfield of New Hanover Co. to collect debts and manage the plantation on the west branch of New River formerly belonging to Jethro Mashborne. (Bell, vol 4, 245 [F312])
- 1741 5. 21 Edward Mashburn petitions for 150 acres in Onslow. (Saunders, vol 4, 594; Cain, vol 8, 120)
- 1741 5. 22 Daniel Mashbourn receives 300 acres in Onslow on Harrys Creek (Hofmann, vol 1 1982, [Bk8 #4314 p106]; Saunders, vol 4, 595; Cain, vol 8, 121) sr
- 1743 Daniel Masborn is listed as a taxpayer in Onslow. (Ratcliff, vol 1 1984, p?)
- 1743 7. 25 Daniel Mashburn petitions for and receives 300 acres in Onslow. (Cain, vol 8, 141; Saunders, vol 4, 635) sr
- 1743 11. 17 Daniel Marshburn petitions for and receives 400 acres in Onslow. (Cain, vol 8, 154; Saunders, vol 4, 649-650)
- 1745 4. 20 William Maynor recieves 400 acres in Onslow on NW branch of New River joining John Sloan and neighboring Jethro Mashburn. (Hofmann, vol 1 1982, [Bk5 #2904 p238])
- 1750 Aug An Aug 2 1750 land transaction in Northampton between Matthew Carter of Johnston and Matthew Mashbourn (no co. given for him) is probated. Witnesses are Benjamin Futrall, John Brown, and Joseph Futrell. (Hofmann, Deeds of Northampton, 71 [Bk1 p442]; original in film #0019420)
- 1751 Oct The will of Henry Rhodes of New River (Onslow Co.) written Sep 14 1751 is probated. He lists his wife Mary and sons Henry and Thomas Rhodes. He also mentions his son-in-law Daniel Mashborn and his granddaughter Elizabeth Mashborn. Executors are Mary Rhodes and Henry Rhodes. (Kammerer, 3) sr
- 1751 Nov Matthew Mashbourne and Samuel Mashbourne are witnesses in Northampton land transaction. (Hofmann, Deeds of Northampton, 79 [Bk1 p504])
- 1753 Jan Jethro Mashborne's will is probated in Onslow Co. Dated Dec 17 1752, he lists his wife Sussanah and his children Mary, Sarah and Edward Mashborne. Executors are wife Sussanah, Charles Cox and Daniel Mashborne. Witnesses are John Jarman, William Whaley and Elizabeth Parker. An interesting note in one book (FHL 975.6 s2gr) is that there was a coat of arms on the seal of Jethro's will. (Kammerer, 3) sr

- 1753 3. 10 Mathew Mashborn helped survey (as sworn chain carrier) 454 acres in Northampton that would go to Massey Wooldridge 20 Feb 1755 as a land grant. (Hofmann, Granville District Grants vol 1, [#3579 p326])
- 1753 May Matthew Mashborn, Charles Cox, and Robert Hutchinson are witnesses to a land transaction dated Aug 22 1752 in Bertie between Jacob Humfreys of Onslow (and wife Martha) and John Brown of Northampton. (Bell, 2nd ed., 221 [G480])
- 1753 5. 30 Mathew Mashborne helped survey (as sworn chain carrier) 392 in Northampton that would go as a land grant to Matthew Powell 9 Nov 1756. (Hofmann, Granville District Grants vol2, [#3514 p306])
- 1754 10. 25 Daniel and Samuel Mashbourn are listed in "a muster roll of forces, retaken at Henry Rhodes'... to serve as militia in a regiment of foot, commanded by John Starkey in Cpt Thomas Hicks' company." (~~CHECK THIS~~ - ~~county~~ - Onslow county) (film #0599260, Clark, Records of NC, 340) sr
- 1755 4. 5 Mathew Mashborne of Northampton deeds to his son Mathew Mashborne Jr. of 320 acres in Northampton. Witnesses for the Aug 1755 probate are James Mashborne and Jacob Lasiter. (A reference in Hofmann's Deeds of Northampton, p113 [Bk2 p226], has the date as 25 Apr 1775; original on film #0019420, Northampton co. Deeds Bk 1-3 [Bk2 p226])
- 1755 4. 12 James Mashborne recieves 200 acres from Massey Wooldridge of Northampton. Witnesses for the Aug 1755 probate are Jacob Lasiter, Matthew Mashborne, and James Laciter. (film #0019420, [Bk2 p230])
- 1755 Aug Matthew Mashborne and Jacob Laciter are witnesses to a land transaction between James Laciter of Northampton and his son James Laciter dated 23 Aug 1755. (Hofmann, Northampton Deeds 1741-1759, 112; original in film #0019420, [Bk2 p225])
- 1755 Aug Mathew Mashborne and Mathew Mashborne Jr. are witnesses to a land transaction in Northampton between James Laciter of Northampton and his daughter Patience Turner. (Hofmann, Deeds of Northampton, 112 [Bk2 p226]; original in film #0019420, [Bk2 p226])
- 1756 3. 20 Mathew Mashborne helped in the surveying of 700 acres (as sworn chain carrier) in Northampton which would go as a land grant to John Futrell 20 Nov 1761. (Hofmann, Granville District Grants vol 2, [#3438 p282])

- 1758 10.7 Mathew Marshburn sat on the jury which served as the inquest of the death of John Jeffery who fell from a horse and was killed. The inquest was held in Northampton. (Roebuck, Inquests, 31)
- 1760 7.2 Deed of gift of 225 acres from Mathew Mashborne of Northampton to his son David Mashborne "now under age" which has a patent dated 11 Nov 1719 joining Uraha Swamp, John Dickinson, Cabbin Branch, Poticasa Creek (deed signed by Mathew Mashborn). Witnesses for the probate are John Turner and Mathew Mashborne Jr. (probated Feb Court 1761; Bradley, Deeds of Northampton 1990, 10 [Bk3 p146-(89)]).
- 1760 12.15 Matthew Mashborne Jr helps survey (as sworn ~~and~~ain carrier) 256 acres in Northampton ("on both sides of Uraha Swamp joining Turners corner, Matthew Mashbourn and Newsom's Marsh") that would go as a grant to John Turner 28 Jul 1761. (Hofmann, Granville District Grants vol 2, [#3561 p320])
- 1760 12.19 Mathew Mashborne of Northampton deeds 320 acres joining Poticassa Creek to William Futral (deed signed by Mathew Mashborne). Witnesses for the probate are John Turner and Benjamin Futral (probated Feb Ct 1761). (Bradley, Deeds of Northampton 1990, 10 [Bk3 p147-(90)])
- 1761 Mathew Mashborne's will of 2 July 1760 is probated in Feb Court 1761 in Northampton Co. He lists his wife Sarah and the following children as still living: Mary (Pinson), Anne, Martha, James, Edward (to whom he gives his still), Sarah (Lassiter), Pricilla, Elizabeth, Charity, Rachel, David (to whom he gives a bed and furniture), Jethro, Daniel, William, and Mathew. He also mentions his grandson James (to whom he gives one 2-year old heiffer), son of Samuel Mashborne who is deceased at the time of the writing of the will. He also gives certain instructions pertaining to his three youngest children. Whether these three were named previously or go unnamed in the will is unclear to me. Note that I have listed the children in the order he gives them with the exception of Mathew who is not named as heir, only as an executor. The executors of the will are his sons Mathew and James. Witnesses are David and John Dickinson and John Turner. (Hofmann, Northampton Wills 1975, [#25 p40]; original will on film #0275901, Northampton Co. Wills, [Bk1 p40]) sr
- 1761 12.5 John Heidleborge receives land in Onslow neighboring Daniel Marshburn and Harry's Creek. (Hofmann, vol 1

1982, [Bk15 #5984 p396])

- 1762 Aug James Mashborne, Joseph Lasater, and William Lasater are witnesses to a deed of gift of 681 acres from James Lasater of Northampton to his grandsons John and Jonas Sharard (sons of dec'd Jonas Sharard) 29 Jul 1762. (Bradley, Deeds of Northampton, 19 [Bk3 p311-(183)])
- 1762 Aug James Mashbourne and Joseph Lasater are witnesses to a deed of gift of 400 acres (+ 80 "where he now lives") from James Lasater of Northampton to his grandson William Lasater (son of dec'd Jacob Lasater) 30 Jul 1762. (Bradley, Deeds of Northampton, 19 [Bk3 p312-(184)])
- 1762 Aug David Mashbourn of Northampton along with Josiah Peeble and William Cook are witnesses to a land transaction dated Dec 23 1762 between John Dickinson and Absolom Hollowell, both of Northampton. (Brazael, 1974, 8 [252]; Bradley, Deeds of Northampton, 27 [Bk3 p433-(252)])
- 1763 11. 23 (11. 3?) Mathew Masburn receives 100 acres in Northampton adjacent James Vinson and Potecasey Creek from William Conner (and wife Martha). Witnesses are Joseph Daniel, William Knight and William Jones. (Bradley, Deeds, 29 [472-(274)]; Brazael, 1975, 39 [274])
- 1764 11.15 Matthew Mashborn of Northampton receives 45 acres from John Turner of the same. The land joins the said Mashborn, James Newsam, Urahah Swamp, and David Mashborn. Witnesses for the probate (Feb Ct 1765) are Charles Thomson, Absolom Mann, and Thomas Mann. (Bradley, Deeds, 36 [577-(361)])
- 1765 Feb Mathew Mashborn, William Boddie, and Israel Campbell are witnesses to a land transaction between John Turner of Northampton and Charles Thomas of same (dated 12 Nov 1764). (Bradley, Deeds, 35 [570-(354)])
- 1765 Feb Mathew Mashburn, Jones Wood, and James Dickinson are witnesses to a land transaction between John Turner (and wife Patience) and John Dickerson the Elder, both planters of Northampton (dated 8 Nov 1764). (Bradley, Deeds, 35 [571-(355)])
- 1765 Feb Matthew Masbourn, Charles Thomason, and Israel Campbell are witnesses to a land transaction (dated 12 Nov 1764) between John Turner and Absalom Mann, both of Northampton. (Bradley, Deeds, 35 [572-(356)])
- 1765 10. 30 Charles Sanders receives land in Craven on cypress branch of Tuckahoe Creek joining next to James

Marshburn, robert Sanders, a small branch and both sides of the mouth of cypress branch. (Hofmann, vol 2 1984, [Bk18 #420 p211])

- 1766 3.7 David Mashbourn (and wife Elizabeth) sells to John Dickinson, both planters of Northampton, 225 acres which was a patent 11 Nov 1719 joining Uraha Swamp, John Dickinson, Cabbin Branch and Pottacasey Creek. Witnesses for the probate (May Ct 1766) are Matthew Mashbourn, William Williams and James Lockhart. (Bradley, Deeds, 41 [651-(430)])
- 1766 Aug In Orange, "David Mashburn granted a license to keep Tavern at his dwelling." (Shields, Minutes of the Court of Orange 1965, 140 [458])
- 1767 10.26 Daniel Marshburn receives 234 acres in Onslow in a fork of the SW branch of New River and Harrys Creek. (Hofmann, vol 2 1984, [Bk23 #6192 p145])
- 1767 Nov Mathew Masbourn, Jonas Wood, and Luke Hall are witnesses to a sale of land from Jeremiah Horton to David Dickinson, both of Northampton (dated 20 Mar 1767). They are 2 tracts which had been willed to said Horton by his father John Horton dec'd and who had purchased it from Francis Parker and Jethro Mashbourn 1 May 1733; 30G acres on north side of Cattawtske Marsh, joining said Dickinson, the old Indian spring, John Dickinson, Edward Mashbourn dec'd, Ready Branch - it was part of a patent to James Bryant Jr. 28 Aug 1714; also 100 acres that said Horton's father, John Horton dec'd purchased from Andrew Irving 22 Oct 1742, joining John Dickinson the Older, Francis Pregien, and Hugh Horton. (Bradley, Deeds, 49 [766-(101)])
- 1767 11.16 Matthew Mashburn sells 212 acres to John Dickinson, son of John, joining Uraha Swamp, Theophilus Pugh, and Joel Newsum. (Matthew Mashburn signed) Witnesses for the Mar 1768 probate are James Murfee, John Tredale and John Dickinson. (Bradley, Deeds, 50 [781-(119)])
- 1769 Edward Mashburn is listed as a taxpayer in Craven. (Ratcliff, vol 1 1984, p?)
- 1769 Edward Marshburn is listed as a taxpayer in Onslow. (Ratcliff, vol 1 1984, p?)
- 1769 Benjamin Marshburn is listed as a taxpayer in Onslow. (Ratcliff, vol 1 1984, p?)
- 1769 Daniel Marshburn is listed as a taxpayer in Onslow. (Ratcliff, vol 1 1984, p?)
- 1769 5.4 James Howard receives 100 acres in Onslow on both sides



of the SW branch of New River joining Nicholas Garganus, William Lester, John Garganus and (a point) opposite Daniel Marshburn. (Hofmann, vol 2 1984, [Bk20 #1767 p470])

- 1769 8. 8 James Mashborne of Orange sells 200 acres to Thomas Futrall of Northampton. The land was part of a deed to said (?) Wooldreidge 20 Feb 1755 joining Parker and Colo Edward. (James Mashborn signed) Witnesses to the Mar 1770 probate are Matthew Mashborn, John Futrall and Henry Warren. (Bradley, Deeds, 61 [965-(12)])
- 1770 Edward Marshburn is listed as a taxpayer in Onslow. (Ratcliff, vol 1 1984, p?)
- 1770 Benjamin Marshburn is listed as a taxpyer in Onslow. (Ratcliff, vol 1 1984, p?)
- 1770 Daniel Marshburn is listed as a taxpayer in Onslow. (Ratcliff, vol 1 1984, p?)
- 1770 James Marshburn is listed in the will of John Screws written 10 Aug 1770 and probated in Sept Court 1770 in Northampton Co. James is given as the cousin of Screws. He is also appointed executor along with "friend" James Butler. His stuff is to go to Martha Carter which at her death will go to James - more stuff goes to Martha and some to Screws' brother's and sister's children. (Hofmann, Northampton Wills 1975, [#119 p182])
- 1771 Edward Marshburn is listed as a taxpayer in Onslow along with 2 negro slaves Peter and Kate. (Ratcliff, vol 2 1987, p?; Kammerer, 12-13)
- 1771 Benjamin and Samuel Mashbern are listed as taxpayers in Onslow without slaves. (Ratcliff, vol 2 1987, p?; Kammerer, 12-13)
- 1771 Daniel Mashbern (and it would appear with three sons) is listed as a taxpayer in Onslow with negroes Ned, Jack, Peg, and Dina. (Ratcliff, vol 2 1987, p?; Kammerer, 12-13)
- 1771 Mathew Masborn is listed in the tax list of Onslow together with an Obed Williams and 3 negroes. (Kammerer, 17)
- 1773 12. 18 James Mashborne of Craven deeds 300 acres (there seems to be something about a Campbell in the original deed that I couldn't read) to John Dickinson of Northampton. Witnesses for the Apr 1775 probate are Benj Brown, James Dickinson, and James Finger. (microfilm #0019422, Northampton Co. NC Deeds vol 6-8, [Bk6 p40])

- 1775 2. 28 Daniel Marshburn receives 300 acres in Onslow "on the S side of the SW branch of New River being the Surplus Land between Marshburn's own lines, joining Harry's Creek and (a point) near James Howard." (Hofmann, vol 2 1982, [Bk26 #8946 p179])
- 1777 2. 8 Edward Mashborne enlisted as a private in Raiford's Company of Col James Armstrong's 8th Regiment for 3 years. One reference has "Omtd" Feb 1778. I have no idea what this means. (Saunders, vol 16, 1114; NC DAR, Roster of Soldiers, 99) sr
- 1778 9. 3 John Mashburn of New Hanover enlists in the N.C. militia. This seems to be an enlistment record in Halifax. His height is given as "-- ft 8 in" (probably 5 ft), age: 30, hair: black, and eyes: brown. His "place of abode" and "where born" both state New Hanover. (Kammerer, 41)
- 1778 Nov James Mashburn among list of men to work on "opening new Road from Caswell County Line to the Widow Woods near Mr William Johnston's" in Orange. (Redden, Minutes of Inferior Court of Orange 1966, 28 [p58.5])
- 1779 Daniel Mashburn is listed as a taxpayer in Hertford. (Ratcliff, vol 2 1987, p?)
- 1779 James Mashburn is listed as a taxpayer in Orange (Ratcliff, vol 2 1987, p?)
- 1779 Jethro Mashburn is listed as a taxpayer in Hertford. (Ratcliff, vol 2 1987, p?)
- 1779 Matthew Mashburn is listed as a taxpayer in Hertford. (Ratcliff, vol 2 1987, p?)
- 1780 James Mashburn is listed with 3 horses and 7 cattle with 266 pounds taxable. He is living in St. Mary's District of Orange Co., the northeast corner of that county. (McBride, Orange 1985, 154)
- 1781 5. 19 William Mashburn enlisted as a private in Carter's company of col Abraham Shepard's 10th Regiment for 12 months. (Saunders, vol 16, 1120; NC DAR, Roster of Soldiers, 147,184) sr
- 1781 12. 1 Thomas Mashborn is named co-executor of Joseph Loyd's will in Onslow. - 1786 4.4 Thomas Mashborne is a resident of Onslow. Included in his home are 1 male between 21 and 60, 2 males either younger than 21 or older than 60, 5 females and 3 slaves. (1786 State Census, p?)
- 1786 Apr Christopher Mashburn is listed in Duplin with 1 male between 21 and 60 and 5 females. (Kenan, State Census 1973, p?)
- 1786 5. 8 Jethro Mashborne/Masborn buys 50 acres from William Mann, both of Northampton. Witnesses to the Dec 1786 probate are Joseph Bridgers and John Bridgers. (film #0019422, Northampton Deeds vol 6-8, [Bk7 p398])
- 1786 James Mashburn is listed in Jones census. In his household there are 1 male between 21 and 60, 3 males younger than 21 or older than 60, 4 females, and no

- 1801 Jul Henry Marshburn's (of Onslow) will, dated 23 Feb 1801, is probated. He lists his wife Ann and sons James, Daniel, and Henry; his daughters are: Mary, Nancy, Reba, Elizabeth, and Sary. Executors are his wife Ann and Joseph. (film #0019445, [Bk A p91-2])

- 1801 9.16 Rachael Mashborn and Britton Ellis receive a marriage bond in Onslow. (Gwynn, sec 22 of Brides Index, p?)
- 1812 Oct Matthew Masburn and Esther Pickett are witnesses to a deed in Duplin. (Draughon, [Bk4A, p504])
- 1812 12.23 William Marshburn and Jethro Marshburn, both of Hertford sell 100 acres to Israel Martin of Northampton. Witnesses to the Mar 1813 probate are Zacheus Martin and James Martin. (film #0019425, Northampton Deeds vol 15-17, [Bk16 p223])
- 1813 James Mashbourn/Masburn of Jones is listed in Cpt Abner Pasteur's regiment. (Roebuck, Defenders, 67)
- 1815 Feb The will of Benjamin Marshburn of New Hanover (dated 29 Nov 1807) is probated. He lists his nephew James Marshburn and gives to "brother and sister 25 shillings" without naming them. Executor is James Marshburn and witnesses are Thomas C. Howe and Thomas Bishop. (Graves, p?)
- 1815 2.1 Susannah Mashbourn and John Gurganus receive a marriage bond in Onslow. (Gwynn, sec 33 of Brides Index, p?)
- 1815 12.6 Caty Masburn and Edmond Ballae receive a marriage bond in Johnston. The bondsman was Theophilus Bagley.
- 1816 Jan Joseph Mashborne of Onslow has his will (dated 7 Nov 1815) probated. He lists his wife Penelope and children Henry (who inherits Lee land), Daniel (who inherits land bought from Jonathan Bryans), Joseph (who inherits land on S side of SW branch of New River), and Mary. He gives his son-in-law as Isaac Trott. In the will he seems to indicate that these four are his only children implying that Mary is married to this Isaac Trott. - 1820 8.2 Susan Marshbourn and Moses Jarman receive a marriage bond in Onslow. (Gwynn, sec 47 of Brides Index, p?)
- 1824 2.19 Benjamin Mashburn of Onslow writes his will (no probate date). He includes his wife Hannah and children James, Hardy, Redden, Benjamin, Nancy, Mary, and Hannah. His

executors are his brother-in-law, Ely Cox and son James Mashburn. Testators are Isaac Brown, Ely Cox, and Priscilla Cox. (Gwynn, 724)

Ballance, "Edmon Ballance's children and Siller Masbern," Haizl Ballance, Caty Ballance, Marth Pitman, and Mourning Kirby. Unfortunately, she gives no relationships. Executor is Edmund Ballance. Witness are John Pugh and Aseneth Revell. (film #0019227, Johnston Co Rec of Wills vol 1 1760-1859, [542])
- 1843 Nov William Mashbourn appointed overseer of road from Neuse River bridge to Josiah O. Watson in Johnston. (Haun,

Book 17 1974, [54])

- 1844 5.27 Edmund Ballance assigned to be the executor of the estate of Sarah Masbone in Johnston. (Haun, Book 17 1974, [81])
- 1844 8.26 Edmund Ballance returns an inventory of the estate of Sarah Mashborn in Johnston. (Haun, Book 17 1974, [100])
- 1846 1.27 William Mashbourn of Johnston sells 129 acres of land to John Corbit of Johnston in Johnston. Witnesses to the Feb 1846 probate are JG Gulley and Blake Atkinson. (Haun, Book 17 1974, [238]; film #0294955, Johnston Co NC Rec of Deeds vol U2 1842-6, [517])
- 1846 May Elbert A. Bryan appointed overseer of road with the same hands as those that worked for William Mashbourn. (Haun, Book 17 1974, [253])
- 1847 11.3 William Marshborn of Wake sells 116 acres to Elias Barnes of Johnston. Witnesses for the Feb 1850 probate are BC Richardson and James W. Giles. (film #0294955, vol V2 1846-50, p?)

I do not pretend that this is in any way an exhaustive bibliography. I have tried to include the most productive sources which I have consulted in my research of the Mashburn/Marshburn family, but of course those books which I looked through and found little or nothing, I have simply left out. Perhaps it is better that way since someone a bit more thorough than I may find something useful in the books I am omitting from this bibliography.

I should also point out the abbreviations which I use in what follows. After most of the entries, I give the call number of the book I used. I used two libraries which used different numbering systems. "FHL" refers to the Family History Library in Salt Lake City, Utah and "BYU" refers to the Genealogical Branch Library located in the Harold B. Lee library on the BYU campus. One or two references have "LC" which refers to the Library of Congress. Although some of the references can be found at both libraries, I only include one call number. Should the other be needed, finding it is not too difficult once one has the title and author of the book. Occasionally, I use film numbers instead of call numbers. This numbering is uniform for both libraries and all Branch Libraries of the Church. Also, if the book was on the shelves as well as having a microfilm number, I only used the call number as the film number is found relatively easily using the Family History Library Catalog.
