Present His Majesties Justices. In the attachment broght by William Little assigner vs John Kelley for 60 pds. Sterling the Execution against the goods of the defendent being Returned mulla Bina(?) the plantiff prayed that appraisers be (appt.) to appraise land of defendent.. pursuant an act of assembly against fugitive...the following persons (appt'd.) James Millikin, John Law, John Bobbit, George Smith, Andrew Ireland, Peter Jones, William Baldwin, William Hodges or any six of them...to evaluate land of defendent...Copy Rt. Forster, clerk".

"November 20, 1730

...lands of John Kelley...to be the same value in Satisfaction the Judgement before me....Signed Thomas Bryant

We...appraisers value the land of John Kelley...200 acres on Occaneche Neck where said Kelley formerly lived and reversion of 50 acres to Roger Case during life where Case sometimes lived...Land being part of patent surveyed to Kelley...below lands of John Cotton...valued at 23 pds. sterling.. John Lanc, Andrew Ireland, George Smith, William Balwin, Peter Jones, William Hodges " (note: name could be Holley).
