December 15, 1726. 400 A. "... for and in consideration of the rents and covenants hereinafter to be paid done and performed...land at Little Town whereon Lewis Williams father of the above Priscilla lately lived and dwelt and by his last will and testament devised to ... Priscilla..." Baker to have "...for and during the natural lives of Henry Baker, Jun. son of said Henry Baker, John Baker another of the sons of said Henry Baker, and John Pugh, son of Francis Pugh...and during the life of the longest liver of them...paying yearly and every year...unto Peter and Priscilla...on the Feast of the Nativity...the rent of one eare of Indian Corn..." Wit: John _____, Robert Radford, Richard Barfield. February Court 1726.*.
- B,217 WILLIAM POPE of Virginia TO BARNABEE MACKINNE, JUN.
. 20 pds. for 100 A. On SS Merrattock River at Tuckahoe Marsh. Land formerly granted to William Jones by patent dated April 5, 1720, and by him elapsed for want of seating. Coming to said Jones by patent dated April 1, 1723. Wit: Barnabee Mackinne, John Mackinne. February Court 1726..
- B,218 JOHN BROWN & JACOB BROWN TO BARNABEE MACKINNE, JUN.
*. 40 pds. For 525 A. On SS Merattock River. Land formerly taken up by William Brown and by him devised in his last will and testament to his son Jacob Brown. Lost and due to his son John Brown by patent dated March 30, 1721. Adj. William Brown dec'd., John Brown, Cypress Gut. Wit: John Mackinne, Isaac Ricks. February Court 1726. *.

September 25, 1726. Grant. 178 A. Adj. Major West. Land formerly granted to Coll. Thomas Pollock by patent granted April 5, 1720 "...and by him elapsed for not seating and planting..." - B,223 AMBROSE AIRES (ARRISS) & WIFE MARY WHITE TO THOMAS POWELL
April 8, 1727. 15 barrels of pitch for 178 A. Adj. land formerly Coll. Robert West's called "New Market" on Cashay Swamp. Wit: Samuel Herring, Ann Herring. May Court 1727. Coll. Robert West by virtue power of atty. ack. in open court. *.
