(283) JOHN HARRELL

Inventory (undated) by George House, exr. Division of estate Nov., 1781 among (1) his sister Winne Harrell, (2) his half-brother George Williams, and (3) Thomas House, son of his sister Rutha House.

Petition (Aug., 1792) by Winifred Harrell, sister of the dec'd., stating the dec'd. died in 1781 testate and left her a mare and other property to divide between her and George Williams, who had since died.

(284) JOHN HARRAELL (HARRELL)

Inventory (undated) by Belis Harrell and Lamuel Harrell. (Court minutes reveal this inventory was filed in June, 1768.)

(285) JOHN HARRELL, JR.

Inventory April, 1756 by Israel Hardy Harrell, including one grist mill and Negroes Sam, Phillis, Cato, Judy and Ned. Division of estate July 23, 1756, noting that most of the estate had been dispersed in legacies, and this division was made by Richard Williams, David Harrell and Elias Hodge.

(286) JOHN HARRELL, SR.

Inventory April, 1759 by Jesse Harrell and Josiah Harrell, mentioning Negroes Pat, Bet, Rachel, Sambo, Gimme, Jinne, Filis, Jack and Will.

(It appears there was litigation involving this estate, for the following depositions are included in this file:) Deposition (Apr. 29, 1805) by Col. Thomas Pugh, stating the following the dec'd. John Harrell, Sr. had seven sons- John, Jesse, David, Esias, Josiah, Ezekiel and Israel Hardy Harrell. John the younger died "many years ago" and left a son George Harrell who moved away. John Harrell, Sr., made a deed of gift to his sons David, Esias, Ezekiel and Josiah, and they thus had possession of their father's land during his lifetime. Jesse Harrell had sons Josiah, Joshua and Jonathan Harrell. David Harrell had sons David and Noah Harrell, and this David Harrell had in his possession the land given by his grandfather John Harrell, Sr. Noah Harrell (son of David Harrell) died without issue. Col. Pugh did not know if David Harrell (son of David Harrell) left heirs. David Harrell (son of John Harrell, Sr.) also had daughters named Milley and others, and they were all dead except Milley who had married Jeremiah Mitchell, and Sarah who had married Josiah Harrell first and second to William Harrell, leaving issue by both husbands. Two other children of David Harrell (son of John Harrell, Sr.) were Chloe and Cherry Harrell, who died without issue. Esias Harrell (son of John Harrell, Sr.) left a daughter who had married William House and died without issue, and the said House was in possession of that share of the land. Josiah Harrell (son of John Harrell, Sr.) left sons Josiah and William Harrell who both left issue. Ezekiel Harrell (son of John Harrell, Sr.) had a son Hardy Harrell, who died without issue, and a daughter Grace who married a Mr. Pearce. Israel Hardy Harrell (son of John Harrell, Sr.) died as a young man prior to his father's death, and without issue. Deposition (Apr. 29, 1805) by Elizabeth Bryant, shows the following information: David Harrell (son of John Harrell, Sr. had children John, Eady (died young), David (died without issue), Cherry (md. Jeremiah Mitchell and had only one child who died young) and Sarah, who married first Josiah Harrell and left daughters Fanny, who married Gabriel Harrell, and Anna who married Richard Veale. By her second marriage with William Harrell, Sarah left issue Joseph and Sarah Harrell. Ezias Harrell (son of John Harrell, Sr.) married the said Elizabeth Bryant and left two children- Ezias (died young) and Sarah, who married William House and had only one child, who was born dead. Ezekiel Harrell (son of John Harrell, Sr.) left two children- Hardy (who died without issue) and Grace, who married John Pearce and left issue Simon Pearce and a daughter who died young.

Deposition (Apr. 29, 1805) by Ansley Montgomery, stating she had lived in the household of David Harrell, dec'd., and revealing the following additional information: David Harrell (son of John Harrell, Sr.) had the following children: David (died without issue), Noah (died without issue), Charity (died without issue), Sarah (married Josiah Harrell), Mille (married Jeremiah Mitchell but left no issue, but was still living in 1805) and Cloe (died without issue). Josiah Harrell (son of John Harrell, Sr.) left a son Solomon Harrell who died "about 27 or 28 years ago."

Deposition (Apr. 29, 1805) by Alice Owens, agreeing with the former statements, but adding that Joseph and Sally Harrell (children of William and Sarah Harrell) were infants in 1805. She also added that Josiah Harrell (son of John Harrell, Sr.) was twice married. By his first wife he had children Solomon (died without issue), Josiah (married Sarah Harrell, daughter of David Harrell), William Harrell (who married his brother Josiah's widow), and Celia (died without issue), Penelope (married Lewis Bryant, but all their children were dead except one who lived in Georgia). By his second wife, Josiah Harrell had a son Jesse Harrell, who was living in 1805.

Deposition (Apr. 29, 1805) by Ezekiel Harrell (son of John Harrell, Sr.) agrees with the preceding statements, but adds that Grace Pearce was dead in 1805.

Deposition (Apr. 29, 1805) by Rachel Pearce agrees with the preceding statements.

Deposition (Oct. 29, 1804) by Milley Mitchell, aged about 43 or 44, agrees with the preceding statements.

(287) JOSEPH HARRELL

Inventory Aug. 12, 1754 by Ann (X) Harrell. Division of estate Oct. 15, 1754 between the widow Ann Harrell and the children of the dec'd., namely Joseph, Sarah, Elizabeth, Mary, Ruth, Wineford, John, Job and Ann Harrell. Division of lands Nov. 20, 1761 between James Williams, husband of the widow Ann Harrell, receiving a 1/3 share, and John Harrell, son of the dec'd., who received a 2/3 share. Dower laid off to Abraham Higgs for Ann Williams, former widow of the dec'd., May 20, 1780.

(288) JOSIAH HARROLD (HARRELL)

Court order to divide the estate among the widow Ann Harrold and her five children, according to the will of the dec'd., being land in the Uneroy Marshes, May, 1774.

(289) JOSIAH HARRELL

Administration grtd. Sarah Harrell, Nov. 14, 1783. Account current Apr. 1784. Money was received from Israel Hardy Harrell, Sarah Harrell, Solomon Page and John Hinton. Money was paid to:
