Petition (undated) by Burwell Johnston and wife Rebeccah, John Butler and wife Wynifred, Constant Loyd (widow of Joseph Loyd), and Sarah Hodgson (widow of Shadrick Hodgson), stating they were the daughters of the dec'd., who died testate possessed of a considerable estate. In his will he loaned his wife Rebeccah Pearce his 70 acre plantation where he then lived for her lifetime with reversion to his son Jeremiah Pearce. The said Jeremiah Pearce was supposed to pay the sum of 28 pounds to his brother Thomas Pearce at the death of their mother, the said Rebeccah. William Pearce's will was probated in February, 1775, and John Watson, Sr. and John Watson, Jr. qualified as exrs. Petition further states that at the widow's death, Jeremiah Pearce took possession of the land, both executors died without seeing to it that Jeremiah paid the 28 pounds to his brother Thomas. The said Thomas became a Continental soldier and died intestate without ever receiving the sum of money, and likewise was owed certain wages for his military service as well as land. The petitioners requested their share of the estate of their father William and brother Thomas. Summons (Aug. 20, 1787) of Jeremiah Pearce to respond to the said petition, listing the same petitioners but listing the name of Sarah Hutson instead of Hodgson.
