Summons of Capt. Thomas Bryant to appear in Court to answer charges that the orphan of the dec'd. (unnamed) was bound to him contrary to law, Sept. 5, 1734.

(108) EDWARD BUNCOMB

File contains a summons of Cullen Pollock (exr. of the dec'd.) to answer to Nehemiah Long, Sept. 18, 1784, Feb. 9, 1785. Summons of Cullen Pollock (exr. of the dec'd.) to answer to Benjamin Stedman, Aug. 8, 1785. Judgment against the goods of the dec'd. in favor of Jonathan Jacocks, exr. of Charles Worth Jacocks, dec'd., Aug. 9, 1784. Summons of Cullen Pollock (exr. of the dec'd.) to answer to Michael Stearn, Aug. 15, 1783. File contains many similar summons.

Inventory June 2, 1781 by John Burn and James Burn. Account of Miss Ann Burn from May 10, 1782 to May 17, 1786, filed by James Burn; money was received for the hire of Sesur to John Hopkins, Rachel to John Yeats, Jude to Joseph West, and Nan to John Belote, all in 1782. Money was paid to Miss Mary Lockhart, Mrs. Worley, Dr. Wall and Carter Harris. Money was received for hire of Nan to Hardy Lewis for 1784, for hire of Nan to George Capehart in 1785, for hire of Jude to Jonathan Jacocks in 1785, for hire of Jude to Jesse Hardy in 1786, and for hire of Rachel to Mr. Yeats in 1786. Money was also received from John Belote and Charles Hodgson. Inventory Aug. 15, 1786 by John Burn and James Burn. Record of a case in the Superior Court of Law and Equity by John Hopkins and Abner Perry against the estate of the dec'd., Aug. 23, 1786. Division (Nov. 3, 1786) as follows: (1) Levy Burn, receiving 200 acres and Negroes Harry and Bess, (2) "John Burn Lottery", and (3) James Burn, receiving Negro Sary. Account for Ann Burn filed by the exr. from June 16, 1786 to Feb. 1, 1787, mentioning money paid Samuel Cook for going to Virginia, Mr. Dwyer, and Henry Hill; money was received from George Capehart, George Outlaw, William Benson and William Yates.
