There are also a number of documents in this Collection for Wayne County, which were not abstracted as Wayne County deeds and wills have been abstracted.

1. 21 February 1793 or 1799 - Lenoir County - We, Wm. WOOTEN and STEPHEN WHITE in consideration of 200 spanish mill dollars sold to JOHN IVEY, one Negro girl, GRACE, about 17 years old
