

c1763 To Ezekial and Ann Causey in Edgecombe and moved from Edgecombe Co. NC after 1820 to Bladen Co. NC by 1830. He is listed in Sampson Co. in a 1831 deed. Ann wrote her will in 1800.

CHESNUTT, Alexander, Private, NC Militia. Soldier is listed in Pearce' Register for the Wilmington District and in the 1790 Census for Sampson Co. NC. Alexander patented land in Duplin in 1756 and this would put his YOB at 1730, However, one son Alexander is identified and likely was born about 1760 and likely this was the Revolutionary War Militiaman and not his dad. The wife of Alexander Sr. was Sarah Murphey in 1757. Alexander Jr. married Sarah Carr and they had 1-Jonathan 1790, 2-Edith 1794, 3-Joseph 1799 and 4-Jennet 1800. Alexander Jr. moved to Anson Co. NC and died in 1812.

CHESNUTT, Joseph, Private, NC Line. Soldier was born about 1752 and the son of Alexander Sr. and Sarah Chesnutt. He died about 1780 in NY as a POW. His heirs were awarded 640 acres.

CLARK, James, Private, NC Militia. Soldier was the son of John Clark who died in 1767. Soldier drew a pay voucher for the Revolutionary War and is listed in 1790 Census for Sampson Co. and Pierce' Register. James married by 1790, Mary Wright.

CLARK Nathan, Duplin Militia. Soldier listed in Pierce' Register for the Wilmington District and 1790 Census for Sampson County with four children. Nathan was the son of John Clark who died in 1767. Soldier married Rebecca Byrd in 1785.

COLE, William, Private, Duplin Militia. This soldier had at least one pay vouchers. He is listed in the 1790 Census for Sampson and married Sally about 1760 and had issue: 1-Patsey Hollingsworth who married Thomas Hollingsworth, 2-William Cole Jr., 3-Nanna Hobbs who married George Hobbs, and 4-Sarah Cole. Soldier wrote his Will in 1807 and died then in Sampson.

COOK, Reuben, Private, NC Militia. Soldier was born 1760 and died 7-21-1856. He married Elizabeth Harrison. Soldier had one pay voucher.

CROOM, Elijah, Private, NC Militia. Elijah Croom drew one pay voucher for 2 pounds and four shillings. Elijah also served in Dobbs and

lived there some. He was living in Duplin in the 1786 state census. He is listed as marring Katy Herring on Aug. 4, 1777. No other known record.

CROOM, Major Sr., Private, NC Militia. Soldier drew three pay vouchers of about six pounds total. He owned land in Duplin from 1764 to about 1790 but it appears he never lived in Duplin as did some of his sons. His first wife was Olive Avery: His known sons are: 1-Joshua 1744-1800 married Nancy, 2-John 1750-1780+, 3-Major Jr. 1755-1810+, 4-Asa 1757-1784+and 5-Isaac Croom 1759-1799. Major then married Susannah Hardy Enloe: issue 6-Richard, 7-Hardee, 8-William 1771-1828, and 9-James Frederick Croom. Likely RS Elijah Croom was a son but not listed as such by researchers.

DANIEL, Aaron, Ensign, SC Militia. There appears to be an Aaron Daniel Sr. and this was the Ensign. There was also an Aaron Daniel in Sampson Co. NC in 1790. Aaron Sr. reportedly was the father of Aaron of Sampson and Elias Daniel of Sampson Co. NC. This family moved about and has been researched some, but much is left to do. Many of the Daniels from Duplin were not born there, moved on to SC, then on the GA. This soldier is listed as being born 1739 in Dobbs Co. NC area, married Elizabeth Whitfield (daughter of Matthew Whitfield), lived in Duplin during the 1760s, and moved to SC by 1774 and died in Cheraw District SC in 1800.

DANIEL, Elias, Private, NC Militia. Soldier(s) had four pay vouchers. Soldier was in Sampson by 1763 and still there 1790 without any children listed. There was an Elias Daniel in 1800 in Wayne Co. NC, Sampson Co. NC, and Bulloch Co. GA. I am sure all three are closely connected. The Elias of GA was born about 1762 in Tyrrell Co. NC, married Elizabeth Pearce in GA in 1786. This Elias died in 1812 in Tattnall Co. GA. Soldier is approved by the DAR.
