



- 057. 7 Mar. 1722 Thomas Alexander to Jonathon Taylor and his father, Thomas Taylor on his account 12,000 lbs. of tobacco in full for "Piney Point's Advantage." Wit: John Bullen, William Skinner, William Ayres.

 Received to be recorded, 1 April 1722. P. Feddeman, Clerk.
- 057. 7 Mar. 1722 Thomas Taylor, Merchant, to his son Jonathon Taylor gift of 150 acres called "Piney Point" on the eastern branch of Treadhaven Creek bought of Thomas Alexander. Wit: John Bullen, William Skinner, William Ayres.
- 057. 7 Mar. 1722 Thomas Taylor acknowledged before John Bullen and Wm. Skinner, Justices. Received by Phil. Feddeman, 1 April, 1722.
- 057. 19 Mar. 1722/3 Robert Welch of Talbot, Planter, to Joseph Harding, Planter 75 acres, part of ye "Wilderness" on the north side of St. Michaels Creek adjoining Ralph Dawson; Henry Parker's land called "The Freshes," and land called "New Mill." Wit: Dennis Hopkins, Philip Kersey.
- 058. On Lady Day, 1720 Robert Welsh acknowledged before Nicholas Goldsborough and John Bullen, Justices. Delivered 7 April 1723 to Phil. Feddeman, Clerk.
- 058. 15 Mar. 1722 David Hughes of Talbot, and Mary his wife, to Thomas Ashcroft about four acres, part of "Stoper," on the north side of a certain creek which comes up to the bridge in the main road next adjoining to Thomas Ashcroft's old plantation. Wit: Thomas Smith, Robert Harrison.
- 059. 15 Mar. 1722 David and Mary Hughes acknowledged before William Skinner and Daniel Sherwood. Received to be enrolled 4 April 1723.
- 059. 6 Mar. 1722 John Fellows of Talbot, Planter, to James Horny 100 acres at the head of Treadhaven Creek near Pitts his Bridge part of "Abraham's Lott," formerly laid out for Abraham Hurlock beginning at an oak in the fork of Pitts his Bridge Branch and running to the land of Sharpe. Wit: Thomas Cockayne, Denis Hopkins.
 - 060. 7 Mar. 1722 Acknowledged by John Fellows before Robt. Goldsborough and his Associate Justices. Philip Feddeman, Clerk.
 - 060. 17 Aug. 1722 James Blair, Merchant, in Glasgow, to Benjamin Pemberton, Gent., in Talbot County P/A to demand tobacco due Blair. Wit: John Oldham, Thomas Nowell.
 - 060. 7 Mar. 1722 John Oldham and Thomas Nowell confirmed the signature of James Blair in open court before Robt. Goldsborough and Associates.
 - 060. 1 Aug. 1720 Thomas Camper of Talbot, Planter, to Joseph Wellen -

Bond in amount of 8000 lbs. of tobacco - Camper to find Joseph Wellen and Margarett his wife, meat, drink, washing and lodging and two gallons of rum per year and all other things necessary during their natural lives. Wit: Wm. Harrison, Thomas Richardson.

- 061. 1 Aug. 1720 Confirm to Thomas Camper and Mary his wife, all the personal estate of Joseph Wellen and Margaret his wife.

 MEMO: that before the sealing and delivery of this instrument of writing, Margaret Wellen was deceased but Joseph Wellen is willing to consumate the same to Thomas and Mary Camper. 3 Jan. 1722. Wit: Daniel Sherwood, John Cooper. Delivered to be enrolled 20 Feb. 1722.
- 061. 5 Mar. 1722 Charles the Second, Lord Baron of Baltimore to Henry Bullen of Talbot Commission "to be Our Chief Ferryman for a term of twelve months from this date to daily attend and transport men and horses to receive eighteen pence for each man and horse and nine pence for all on foot, between Henry Bullen's plantation, over the Choptank River to a marsh opposite on the Dorchester side. To give due attendance to the boats, well manned and in constant repair so that none may be detained." NICHOLAS LOWE, Agent.
- 061. 20 April 1723 Ann Swallow of Talbot, Spinster, to John Clift of Talbot, Planter 139 acres, "Timber Neck Addition," on the branches of Miles Creek back in the woods adjoining "Timber Neck" and land called "Taylor's Ridge." Wit: William White, Terrence Connolly.
- 062. 20 Apr. 1723 Ann Swallow to John Clift receipt of £25 in full. Wit: Wm. White, Terrence Connolly.
- 062. 20 Apr. 1723 Ann Swallow acknowledged before John Bullen and Nicholas Goldsborough. Delivered to Philip Feddeman, Clerk, 23 Apr. 1723.
- 062. Cecilius, Lord Baltimore, to John Smith, William Robinson and George Watts of Nomeny Plantation hath due 1000 acres by assignment from William Smith, Carpenter, under the conditions of plantation dated at London, 2 July 1649 declared 22 Sept. 1650, a grant to the above of a parcel of land called "Nominy" in Talbot County, north side of Great Choptank River in the southern branch of St, Michaels Creek about four miles above the second turn of the River containing 1100 acres.
- 063. On the back of the Patent: John Smith to Robert Skinner of Bristoll, Merchant his share of the patent, 4 Jan. 1664. Wit: Edward Hull, John Chase.
- 063. Robart Skinner to Solomon Thomas assignment of his interest in the land called "Nominy," 20 Dec. 1673. Wit: John Richards, Richard White.
- 063. Received 1 May 1723 of William Edmondson of Dorchester County a certificate dated at London 29 Aug. 1721 to discharge Capt. Welland's ______ bond which was past here 15 June 1721. R. Ungle. (Na. Off.)
