E 441 JAMES WOOD TO WILLIAM DUFFIELD & WIFE SARAH
 May 9, 1739. Gift. 500 A. "...love good will and affection I bear unto
 my well beloved Son in Law William Duffill and Sarah his wife...during their
 Natural Lives...". Land at a branch called Harriss's Branch adj. Richard
 Brasswell, Jonathan Stanley. Wit: Andrew Irwing, Robert Forster, John Sutton.
 May Court 1739. *. (Note: This propert lent for life "after their decease
 to be Equally Divided between...(their) two eldest Daughters...".)

E 441 GEORGE WYNNS TO JOSEPH WYNNS
 November 10, 1738. Gift. 100 A. "...love...unto my Son Joseph Wynns...".
 Land on NS Wiccacon Creek at "mouth of the said Joseph Wynns Hill Swamp".
 At Horse Hung Branch. Wit: Benjamin Wynns, Culmur Sessams, jurat. May Court
 1739. *.

E 442 JOHN WYNNS, yeoman, TO JOSEPH WYNNS
 November 10, 1738. 40 pds. for 280 A. On NS Wiccacon Creek "at mouth
 of Germans will Branch" at Horse Hung Branch. Adj. Joseph Wynns, Culmur
 Sessams, Edward Hanes, John Brown, "Bushes former Land". Wit: Benjamin
 Wynns, W. Wynns. May Court 1739. *.

E 444 JOSEPH WYNNS TO CULMUR SESSUMS, yeoman
 November 11, 1738. 70 pds. for 150 A. On NS Wiccacon Creek at Mill
 Swamp at the "Main Road to the Head Line of the survey of the Germans Land".
 Adj. Edward Hanes, "Culmer Sessums other land". Wit: John Wynns, Benjamin
 Wynns. May Court 1739. *.

E 445 JOHN WYNNS, yeoman, TO WILLIAM WYNNS
 May 1, 1739. 300 pds. for 450 A. Land called "Ahotskey Ridge" adj.
 Cathcart, "to land which I purchased from Swanner". The same land
 conveyed to Wynns by Matthew Tobias Swanner by Deed dated July 31, 1738.
 Wit: Peter West, J. Edwards. May Court 1739. *.
