July 1, 1738. Gift. Household goods. "...love good will and affection ...towards my well beloved Child Martha Parker...one good Bed and furniture and one Large Chest with a Drawer in it and one small red Leather Gilded trunk and one great Tankard and one Pottle Brass skillet and two Large Pewter Dishes Marked Thus AM and MW and one good Pewter Poringer and salt seller and one small Bason marked Thus X and Two Large basons marked Thus X and five pewter plates Marked Thus X and two Cows and Calves and half their Increase and one Iron Pot holding about five gallons & one Iron Kettle holding about a gallon & a half and a good Box Iron with a Brass Knob and Heaters..." To her and her lawful begotten heirs. Wit: John Battle, John Brown, jurat. February Court 1738. \*.

## E 395 LITTLETON SPIVEY TO EALEE THOMAS

November 13, 1738. 30 pds. for 220 A. On NS Morrattock River adj. James Bents, Thomas Busbys. To a dividing line between Spivey and Page. Wit: George House, James Carter, Luke Thomas, jurat. February Court 1738. \*.

## E 397 JAMES ROADS TO JOHN VICKINS

December 29, 1738. 30 pds. for 250 A. Adj. William Rutons "to a Tarkiln". Wit: J. Early, Jun., William Rasberry. February Court 1738. \*.

## E 398 HENRY BONNER TO JAMES WOOD

November 20, 1738. 200 pds. for 400 A. At Ahotskey Swamp. Adj. Charles Jones. Wit: Abraham O'dham, John Sutton, jurat. February Court 1738. \*.

## E 400 WILLIAM CHARLTON of Craven Precinct TO EDWARD FRISBIE

February 19, 1738. 70 pds. for 100 A. "Patented in the name John Harlow and sold by Harlow to William Coward deceased and sold by John Coward to Joseph White...". Adj. Edward Frisbie. Wit: Francis Penvin, John Warbullan. N.C. Court March 31, 1739. W. Smith, C.J.

## E 401 JAMES CASTELLAW TO JOHN STAFFORD of Nansemond Co., Va., merchant

August 4, 1738. 800 pds. for 640 A. On Meherrin Creek. Which land Castellaw bought of John Beverly and which was granted to Beverly by patent dated March 1, 1720. Wit: Robert Forster, Thomas Banker(?Barker), Thomas Jackson. August Court 1739. John Wynns D.C/C.
