Isaac was older than Sarah. He and his first wife Ann were already married; Sarah, single, in list of headrights for father Robert's North Carolina landgrant. It was proved up in 1694, as very many were that reflected an earlier immigration into North Carolina. The entry dates were not recorded. Reference - Old Albermarle

Co. NC Book of Land Warrants and Survys, 1681-1706, Weynette Parks Haun, transcribed from S.S.978.1 North Carolina State Archives, Raleigh, NC.

The following references in Encyclopedia of American Quaker Genealogy by William Wade Hinshaw, Vol I, lead me to believe Robert and Ann were living in North Carolina at least by 1681.

Marshall's Additions, P. 5 - Robert Wilson was one of those chosen by the Perquimans Monthly Meeting to help settle a dispute, 10, 7th mo. (Sep) 1681.

P. 1. (In introduction to Perquimans MM) Robert and Ann signed as witnesses at the marriage of William Bundy and Mary Pierce, 15, 10th mo. (Dec) 1683.

P. 36 - Sarah Wilson and John Belman both of Perquimance were married 19, 8th mo. (Oct) 1687

I think Robert and Ann Wilson must have gone as guests to the "Nanzemund" Virginia Meeting on the 19th day of the 12th mo. (Feb) 1688 when they were recorded as witnessing the marriage of Leaven Bufkin and Dorrithy Newby. Sometimes this Virginia reference has been mentioned as the very first reference to the existence to Robert and Ann. Early Quaker Records in Virginia compiled by Miles White, Jr, Gen. Pub. Co. Baltimore, 1979.

Mrs. Watson Winslow is in error in her History of Perquimans County when she wrote that our Ann Wilson was the daughter of Thomas Blount. Both Raymond Winslow, a current North Carolina genealogist and William Perry Johnson, now deceased, who was perhaps the foremost NC genealogist, have said that it could not be so. In North Carolina Higher-Court Records, 1697-1701, p. 124 there is a deposition taken from Thomas Blount in 1697 that he is "betwixt 41 and 42 years (old)." He would be much too young. He did have a daughter Ann Wilson in his will (I have a copy) that he signed in Kendricks Creek, Albermarle Co. NC in 1701. One of the witnesses was a William Wilson. W.P. Johnson said that there were Wilsons in that area,

Kendricks' Creek is in the Chowan County division of the original Albermarle. Chowan County does not abut Virginia, and is at quite a distance from Surrey co. VA where our Ann Wilson spent the last year of her life, as indicated by her will.

I have no idea why Ann Wilson deeded her property in NC (Oct 1701) to son Isaac and son-in-law John Belman and moved to Lawns Creek Parish, Surrey Co. VA. where she left a will signed in July 1702. She leaves to grandchildren who are named for Robert and herself; Robert & Ann Belman and Robert & Ann Wilson, and the "poor Friends belonging to the Meeting in Surry County."
