1791. Sept. 17, 1764 Benjamin Whaley to James Cunningham, taylor (New Bern, NC); "of his own free & voluntary will" Whaley has bound himself to Cunningham for 18 months beginning today; Whaley to serve Cunningham faithfully, obey his lawful commands, not waste his master's property, not haunt taverns or play houses "at cards die or any unlawful games", not damage his master's goods, & not absent himself day or night with out leave; Cunningham is to teach Whaley the "mistry" of a taylor, provide sufficient meat, drink, washing, & lodging, & pay Whaley £22 proclamation money. (signed) Benjamin Whaley & John Cunningham; (witness) Timothy Clear & Saml Griffis; [no wit. oath mentioned]; book 2 p. 505.

1792. May [blank], 1765 William "Greenborough," merchant (Wilmington, New Castle Co "upon" Delaware) to my loving friend Christopher Bickman, store keeper (now bound for North Carolina); power of attorney to recover money due to me by anyone in North Carolina. (signed) William "Green"; (witness) John Latham & Abraham Davis; wit. oath Jul. 1765 by John "Latham"; book 2 p. 506.

1793. Jun. 29, 1765 [Quaker style date] William Stuart (Mitchells Creek, Craven Co) to Parmenus Thorton & Bartholomew Howard, merchants & distillers (Clubfoots Creek, Craven Co); for £31 proclamation money sold 100 ac on S side of Nuce R & W side of Clubfoots Cr; in the fork of Broad Cr or Mitchells Cr; border: begins at mouth of a gut that divides land from Mathew Moor's land late Levi "Boush's" both taken in by a grant to Edmund Mitchell & divided "between" Levi Bush, joins Mitchell's now Stewart's Landing, head line of the patent, & middle of a branch that divides from Mathew Moor; granted (no date) to Edmund Mitchell who sold to Robt Blake who sold to William "Stewart". (signed) William Sturat's mark "X" [or forward & backward "C" that join]; (witness) John Howard & Christr. Neale; wit. oath Jul. 1765 by Chrstopher Neale; book 2 p. 506.

1794. Jul. 19, 1763 [Quaker style date] William Stuart (Clubfoots Creek, Craven Co) to Thomas Frazer (Clubfoots Creek, Craven Co); for £40 proclamation money sold 200 ac on S side of Neuse R & W side of Clubfoots Cr; border: begins at a pine on Robert Blake's line & joins land granted to Edmund Mitchell now Robert Blake's. (signed) William Stuart's mark "F" (sic); (witness) Daniel Frazer & John Tomlinson; wit. oath Jul. 1765 by Daniel Frazer; book 2 p. 507.

1795. Apr. 1, 1765 Cason Brinson jr, planter (Craven Co) to William Heath, "cuper" (same); for £80 proclamation money sold 0.5 ac in lot #247 in New Bern on Broad Street & Craven Street; lot is 6.5 poles by 13 poles; money to be paid within a year with half paid in 6 months and other half at end of a year. (signed) Cason Brinson jr; (witness) Thomas Duncan & George Kennedy; wit. oath Jul. 1765 by Thomas Duncan; book 2 p. 508.

1796. Jul. 29, 1765 Richard Cogdell, high sheriff (Craven Co) to William Good, carpenter (New Bern, NC); for £38.5 proclamation money sold 0.5 ac in lot #72 in New Bern on E side of Handcocks St; sold Mar. 15, 1763 by John Carruthers to Stephen York; sold due to writ of venditioni exponas & 4 writs of fieri facias from Craven Co Pleas & Quarter Sessions Court Apr. 6 last & returnable to court first Tuesday in July next against Stephen York (a) for £3.11.10 proclamation money due to suit by John Bryan, executor of Edward Bryan, (b) £3.11.10 due to suit by John Bryan, (c) for £3.16.8 due to suit by Patrick Stanley, & (d) for £1.18.8 due to suit by Richard Richards; & sold due to act of Parliament of Great Britain in fifth year of reign of George II allowing sheriffs to sell land for debts. (signed) Richd Cogdell; (witness) Wm Herritage & Richd Fenner; [note at end indicates Good paid Cogdell £38.5 Jun. 29, 1765]; Jul. 1765 acknowledged; book 2 p. 509 [bottom of deed at top of p. 543].

1797. Nov 23, 1761 James Barnicastle, planter (Craven Co) to John Stanton, planter (same); for £4.5 proclamation money sold 100 ac on S side of Nuce R & E side of Adams Cr; border: begins at Thomas Moss' corner gum, joins "the" back line, Lipper, & Warner; part of land given (no date) by Thomas Martin to John Pittman who sold to James Barnicastle. (signed) James Barnicastle's mark "X"; (witness) Ja Jones, Samuel Masters, & Solomon Northam; wit. oath Feb. 1761 by Samuel Masters; book 2 p. 511.

1798. Mar. 8, 1762 Garrett Johnston (Craven Co) to Joseph Bryan (same); for £120 proclamation money sold 98 ac; border: begins at an oak on N side of Swifts Cr, joins South of Miery Br, second fork of the branch; where said Garrett Johnston formerly dwelled; part of 200 ac granted in 1735 to Edmond Pearce. (signed) Garrett Johnston; (witness) Joseph James & William Murphey; Jul. 1762 acknowledged; book 2 p. 511.

1799. May 5, 1764 [4th year of reign of George III] George Becton, planter (Craven Co) to my loving father-in-law Samuel Slade, planter (same); for love, good will, & affection gave (a) 300 ac in Dobbs Co; border: joins Capt. William Whitfield's line formerly called Owin Daniel's line and Simon Bright sr [no more description]; & (b) a Negro girl Hannah & a feather bed & furniture, a mare & colt, a two year old horse, & 10 cows & calves. (signed) George Becton; (witness) Samuel Slade jr & Ebenezer Slade; wit. oath Sept. 18, 1764 by Saml Slade jr before Chas Berry; book 2 p. 512.

1800. Apr. 15, 1762 [2nd year of reign of George III] Joseph Fillyaw, planter (Onslow Co, NC) to James Fillyaw (Craven Co); for £12 proclamation money sold 100 ac on S side of Tuckehoe Cr & on Patrick Br; border: begins at a water oak below the fork of Patrick Br and joins William Jones; granted Oct. 21, 1758 to Joseph Loftin. (signed) Joseph Filyaw; (witness) John Jerman & John Knots; wit. oath Oct. 1862 (sic) by John Knots; book 2 p. 513.

1801. Oct. 4, 1764 Timothy Clear, trader (New Bern, NC) before John Clitherall JP swears: he is of lawful age and on Aug. 4, 1760 at New Bern he saw John Kerney deliver to William Bond (of Dobbs Co) a Negro boy Sam; Kerney said he delivered the boy in presence of Timothy Clear on account of services done to Kerney, but if anyone has a better claim to the Negro, Kerney didn't defend the Negro any further. (signed) Timo Clear; book 2 p. 514.

1802. Oct. 20, 1762 Thomas Thomas (Craven Co) to James Caddell, planter (same); for £40 proclamation money sold 100 ac; border: begins at a white oak in a fork of a branch of Flatt Swamp being beginning tree of "the whole" tract, joins "the main" swamp, & mouth of Wilkinsons Br; part of a grant Sept. 9, 1737 to Samuel Buxton who sold to "said" Wilkinson who sold to Thomas Thomas. (signed) Thomas Thomas; (witness) Jonathan McFarson, Francis "Dopps", & Neale Watson; wit. oath Oct. 1764 by Jonathan "McFearson"; book 2 p. 514.

1803. Apr. 6, 1764 Daniel Gordon, gentleman (Dobbs Co, NC) to Phillip Ambrose, merchant (New Bern, Craven Co); power of attorney to recover fom Anthony Van Dam (of New York) money due to me. (signed) David Gordon; (witness) Richd Caswell [only one witness]; wit. oath Oct. 1764 by Richd Caswell; book 2 p. 514.

1804. Sept. 11, 1764 John Bishop the elder (Craven Co) to his son John Bishop jr (same); for £30 proclamation money sold 340 ac on Clubfoots Swamp & S side of Nuce R; known as Bright's cowpens; border: begins "over against" mouth of Fire brand Br at a pine on Blake's line & joins Mitchel; part of 540 ac granted in 1743 to Simon Bright who sold in 1745/6 to John Bishop the elder. (signed) John Bishop; (witness) Alexr Gaston & David James; wit. oath Oct. 1764 by Alexander Gaston; book 2 p. 515.

1805. Oct. 4, 1764 Richard Graham, taylor (Craven Co) to Jeremiah Pritchard [or Pritchett], "marriner" (same); for £59 proclamation money sold 3 tracts: (a) 100 ac [no more description]; part of 212 ac granted Mar. 24, 1747 to James Marshall (or Marshall) who sold Mar. 22, 1751 to James Mathews and sold Dec. 5, 1752 by Peter Mathews to Richard Graham; (b) 100 ac on White oak Pecoson near Samuel Johnston esq; border: begins at James Marshall's corner marked pine; granted Nov. 18, 1757 to Richard Graham; & (c) 100 ac on White oak Pecoson; border: begins at a gum in the pecoson by Coonfes' (sic) line, crosses a savannah, joins Jacobs Peccson, head of the pecoson, near a branch, joins Marshall, & Mathews; granted Sept. 29, 1756 to Richard Graham; all 3 tracts "nigh" White oak Pecoson & near Iron mine Br. (signed) Richard Graham; (witness) Isaac Patridge & Peter Rhem; [note at end indicates Pritchard paid Graham £59 Oct. 4, 1764]; wit. oath Oct. 1764 by Peter Rhem; book 2 p. 516.

1806. Sept. 22, 1764 Silvanus Justice (Craven Co) to my son Joseph Justice (same); for natural love & affection gave 80 ac in 2 tracts: (a) 50 ac on N side of Nuce R & on upper side of Dawsons Cr at head of "the" great branch [no more description]; purchased (no date) from Joseph Atherley; & (b) 30 ac; border: begins at mouth of a small branch

money sold [omitted, maybe 240] ac in an island near fork of Neuse R; border: 640 poles long & 60 poles broad; granted (no date) to John Lovick. (signed) John Reed; (witness) Jos Blount, Charles "Jawcks", & Henry Dendon; Aug. 3, 1745 proved before Enoch Hall, CJ; Sept. 20, 1745 recorded; book 3 p. 112.

2068. Jan. 14, 1744 George Metts, planter (Craven Co) to William Herritage, gentleman (same); for £640 NC money sold (released) 250 ac; border: begins at a pine in fork of North Cr; granted Jul. 30, 1725 by Lords Proprietor to William Wilson who sold Mar. 15, 1725/6 to George Metts, father of grantor of this deed. (signed) George Metts; (witness) Adam Moore & John Harris; [note at end indicates Herritage paid Metts £640 Jan. 14, 1744]; wit. oath Jun. 1745 by Adam Moore; book 3 p. 113.

2069. Jan. 13, 1744 George Metts, planter (Craven Co) to William Herritage, gentleman (same); for £0.5 NC money leased for a year 260 ac; border: begins at a pine in fork of North Cr; granted Jul. 30, 1725 by Lords Proprietor to William Wilson who sold Mar. 15, 1725/6 to George Metts, father of grantor of this deed; quit rent is a grain of Indian corn to be paid on feast of nativity of our Lord Jesus Christ next if demanded. (signed) George Metts; (witness) Adam Moore & John Harris; [note at end indicates Herritage paid Metts £0.5 on Jan. 13, 1744]; book 3 p. 115.

2070. September court 1745 [at top of deed & Sept. 14, 1745 at bottom] Nicholas Colbert, planter (Craven Co) to John Williams, merchant (same); for £100 NC money sold on S side of Neuse R; border: begins at Col. Loftin's corner hickory, runs S30E 99 poles along Francis Mimms' line to sweet gum on Thomas Graves' line, S38E 113 poles to a stake "hard by" a pond, S52 W 155 poles to a stake on Cornelius Loftin's line, & N12E 132 poles to first station; except half of gold & silver [which goes to the king, if found, along with yearly quit rents]. (signed) Nicho. Colbert; (witness) Richard Carlton & William Nunn; wit. oath (no date) by William Nunn; book 3 p. 117.

2071. Aug. 23, 1745 Robert Caldwell, planter (Craven Co) to John Williams, merchant (same); for £400 NC money sold 100 ac on S side of Neuse R; border: begins at run of Stony Br where "the" line crosses the branch granted to Capt. William Hancock who sold to his son William Hancock who sold to Francis Nunn who sold to Thomas White who sold to Robert Caldwell, joins said Hancock's first line, & his patent; where said Caldwell dwells; part of grant Mar. 30, 1721 to William Hancock sr. (signed) Robert Caldwell; (witness) Phil Trapnall, Willis Ship, & Jas Williams; wit. oath (no date) by Willis Ship; book 3 p. 117.

2072. Apr. 9, 1745 William Nunn, planter, & wife Elizabeth (Craven Co) to John Williams, merchant (same); for £0.5 leased for a year 290 ac on S side of Neuse R; called Fort Barnwell; border: begins at a red oak at mouth of Half Moon Swamp, runs up the swamp to mouth of Stony Br, up the branch to an elm in "the" head line, S80E 131 poles to a gum, N10E 320 poles to a red oak on the river, up the river to the low grounds "to first station"; part of 640 ac granted Mar. 30, 1721 by Lords Proprietor to William Hancock the elder who sold Oct. 26, 1728 to William Hancock the younger who sold Sept. 26, 1732 to Francis Nunn who died intestate and land fell to his eldest son William Nunn; quit rent is one grain of Indian corn to be paid at feast of Annunciation of Blessed Virgin Mary if demanded. (signed) William Nunn & Elizabeth Nunn; (witness) Francis Stringer & Thomas "Tuten"; (no date) acknowledged by Wm & Eliza Nunn; book 3 p. 119.

2073. Apr. 10, 1745 William Nunn, planter, & wife Elizabeth (Craven Co) to John Williams, merchant (same); for £850 NC money sold (released) 290 ac on S side of Neuse R; border: begins at a red oak at mouth of Half Moon Swamp, runs up the swamp to mouth of Stony Br, up the branch to an elm in "the" head line, S80E 131 poles to a gum, N10E 320 poles to a red oak on the river, up the river to the low grounds "to first station"; known as Fort Barnwell; part of 640 ac granted Mar. 30, 1721 by Lords Proprietor to William Hancock the elder who sold Oct. 6, 1728 to William Hancock the younger who sold Sept. 26, 1732 to Francis Nunn, father of William Nunn, who died intestate & premises fell to his eldest son said William Nunn. (signed) William Nunn & Elizabeth Nunn; (witness) Francis Stringer & Thomas "Tuten"; (no date) acknowledged by Wm & Eliza Nunn; (no date) recorded; book 3 p. 121.

2074. Jun. 31, 1745 (sic) Hugh Lorrimer (Craven Co) to Thomas Rogerman (same); for £350 sold a third of 5 ac on Mauls Run where "the" saw mill stands; sold (no date) by Lewis Bryan to Hugh Lorrimer; and a third of profits from the mill; provided Rogerman pays a third of all charges and provides a third of timber, attendance, labor, & necessities to carry on the business of sawing & grinding. (signed) Hugh Lorrimer; (witness) James Roach & Lewis Bryan; (no date) acknowledged; book 3 p. 124.

2075. Apr. 1, 1745 Simon "Meorpus" (NC) to William McCoy, planter (Craven Co); for £110 NC money sold 82 ac on N side of Neuse R & E side of Goose Cr; border: begins at William Watson's corner pine. (signed) Simon "Meorpus"; (witness) Garret Hymen, George "Harkill", & Wm Bastin Whitford; wit. oath (no date) by Garret Hymen; book 3 p. 125.

2076. Apr. 1, 1745 Simon Morpus (NC) to William Watson, planter (Craven Co); for £33 NC money sold 93 ac on N side of Neuse R & E side of Goose Cr; border: begins at George Harkit's "line tree" & joins William McCoy. (signed) Simon Morpus; (witness) Garret "Hyman", George Harkit, & Willm Bastin Whitford; wit. oath (no date) by Garret Hyman; book 3 p. 126.

2077. Sept. 18, 1745 Dearham Handcock, cordwainer (Craven Co) to William Wickliffe, merchant (same); for £500 NC money sold 30 ac on S side of Neuse R & E side of Slocombs Cr; border: begins at a poplar near mouth of Slocombs Cr, joins mouth of "the" great run that parts said land from Joseph Slocomb's, "the" back line, Solomon Smith, Sandy Valley, & head of Duck Cr; includes Sandy Point. (signed) Dearham Handcock; (witness) Christopher Yew, Joseph Watt, & John Snead; wit. oath (no date) by John Snead; [note at end indicates Wickliffe paid "Hancock" £50 Sept. 19, 1745 (sic)]; book 3 p. 128.

2078. Feb. 1, 1744 Thomas Lewis (Craven Co) to Godfey Hartfield (same); for £240 NC money sold 90 ac on N side of Neuse R; border: begins at a white oak on Sandy Run. (signed) Thomas Lewis; (witness) John Giles & John Fishpool; wit. oath (no date) by John Giles; book 3 p. 129.

2079. Feb. 16, 1744/5 William Stanley, planer (Craven Co) to Robert Park, merchant (same); for £100 sold 180 ac on N side of Neuse R & E side of Walnut Cr; border: begins at a white oak on said creek, joins head of a meadow, & Bogue Marsh; part of 560 ac survey; Park to pay yearly quit rent of £0.4 proclamation money per 100 ac to the king. (signed) William Stanley; (witness) Daniel "Stieen" & John Herring jr; wit. oath (no date) by John Herring jr; book 3 p. 131.

2080. May 30, 1745 Simon Bright (Craven Co) to John Lovett; for £500 NC money sold 250 ac on S side of Neuse R; border: begins at mouth of Kings Cr & joins Cherry Point Br; Lovett to pay yearly quit rent of £0.0.6 per 100 ac to the king. (signed) Simon Bright; (witness) John Bishop & Paul Phillips; (no date) acknowledged; book 3 p. 133.

2081. Mar. 18, 1744/5 Richard Johnson (Craven Co) to David Journagin [or Journegin] (same); for £70 Virginia money sold 200 ac; border: begins at Henry Owens' corner tree, joins Stony Cr, & Neuse R; part of 300 ac granted Jun. 13, 1739 to Richard Johnson. (signed) Richard Johnson; (witness) John Giles, Abrm Boyd, & Roger Cannon; wit. oath (no date) by John Giles; book 3 p. 134.

2082. Sept. 10, 1745 Catherine Dimmock, widow (NC) to my daughter Catherine Dimmock jr; for love, good will, & affection gave 2 Negro girls "Franck" & Hannah; if Catherine dies without heirs, Negroes to my daughter Betty Dimmock for love & affection; Negroes are now delivered to Catherine Dimmock jr. (signed) Catherine Dimmock; (witness) Francis Stringer & Joseph Miller; wit. oath (no date) by Francis Stringer "esq"; book 3 p. 136.

2083. Sept. 17, 1745 Hugh Stanaland, planter (Craven Co) to John Carruthers esq; for £80 NC money sold 150 ac on N side of Trent R; border: begins at a red oak in Ford Neck & joins Martin Frank; granted Nov. 18, 1743 to [omitted] "now lying in the Secretary's office". (signed) Hugh Stanaland; (witness) John Rice & Patrick Stanaland; (no date) acknowledged; book 3 p. 136.

[no more description]; sold (no date) by John Gatlin jr to me. (signed) Nicholas Dyson; (witness) Robert Park, John Bradley, & Hugh Lorrimer; (no date) acknowledged; book 3 p. 157.

2099. Aug. 30, 1745 Leonel Leigh (Craven Co) to John Phillips (same); for £80 NC money sold 315 ac on S side of Neuse R; border: begins at a gum & joins John Durham. (signed) Leonel Leigh; (witness) John Yeoman & Benja Sanders; wit. oath (no date) by John Yeoman; book 3 p. 158.

2100. Jun. 27, 1745 Simon Bright (Craven Co) to John Wetherington (same); for £75 NC money sold 160 ac on N side of Neuse R & N side of Brirery Br; border: begins at a red oak & joins "Bryery" Br; being a fourth of 640 ac granted in 1739 for Simon Bright. (signed) Simon Bright; (witness) John Rice & John Williams; wit. oath (no date) by John Rice; book 3 p. 159.

2101. Aug. 28, 1745 John Pate, planter (Craven Co) to James Ballard, planter (late of Virginia); for £100 sold 180 ac on N side of Little R; border: begins at a red oak & pine on the river. (signed) John Pate; (witness) Francis Stringer, John Bradley, & Peter "Fitz Patrick"; wit. oath (no date) by Francis Stringer; book 3 p. 160.

2102. Sept. 20, 1745 Walter Lane & William Handcock to James Mills; for £12.13.4 sold 1 ac in lots #192 & 193 in New Bern; border: begins at corner of Pollock Street & Metcalf Street; total is 13 poles by 13 poles; sold due to act of Assembly Nov. 4, 1723 at Edenton to better regulate town of New Bern; Cullen Pollock, Richard Graves, & William Handcock esqs appointed commissioners to sell lots not already taken up; commissioners were allowed to select successor if one died & Walter Lane esq was chosen upon death of Richard Graves; town has privilege of getting timber from the land for town use; Mills to build house on each lot at least 20 feet by 15 feet within 18 months; and Mills to pay a pepper corn annually, if demanded, to grantors; if Mills dies without heirs, land reverts to the town. Sept. 17, 1745 Matthias Risenover, planter (Craven Co) to my grand child Daniel Granade (same); for love, good will, & affection gave 50 ac on S side of Neuse R & in a place called Reedy Neck; border: begins at a beach tree, joins the pocoson, & the grant [no more description]; part of 100 ac granted (no date) to me. (signed) Matthias Risenover; (witness) James Durham & Jacob Slobock; (no date) acknowledged; book 3 p. 165.

2105. Sept. 16, 1745 Catherine Dimmock, widow (Craven Co) to Mark Cole, planter (same); for £106.6 sold 200 ac on N side of Neuse R & S side of Rainbow Cr; border: begins at a pine by the creek, joins a marshy branch, & great branch; Cole to pay yearly quit rent of £0.4 proclamation money to the king. (signed) Catherine Dimmock; (witness) Francis Stringer, Joseph Miller, & John Powell; wit. oath (no date) by John Powell; book 3 p. 166.

2106. Sept. 17, 1745 John Herring jr, planter (Craven Co) to Thomas Jones (same); for £200 NC money sold 300 ac on N side of Neuse R & W side of Bear Cr; border: begins at a white oak near mouth of "the" marsh. (signed) John Herring jr; (witness) John Williams & James Williams; (no date) acknowledged; book 3 p. 167.

2107. Aug. 30, 1745 John Fryer, merchant (Craven Co) to Joseph Richd. Hickson, school master; for £60 NC money sold 60 ac on N side of Neuse R & E side of Bear Cr; border: begins at a red oak near E end of Joseph Rd Hickson's school house; part of 320 ac owned by John Fryer; Hickson to pay yearly quit rent of £0.4 proclamation money per 100 ac to the king. (signed) John Fryer; (witness) Thomas Jones & William Fryer; wit. oath (no date) by Thomas Jones; book 3 p. 169.

2108. Sept. 9, 1745 Henry Jernigan (Craven Co) to Bennett Blackman (same); for £13 sold 150 ac on S side of Neuse R; border: begins at Jacob "Jarnigan's" corner gum on "the" side of a pocoson, joins courses of the patent, & a marsh. (signed) Henry Jernigan; (witness) Mark Phillips & W Rhoads; wit. oath (no date) by Mark Phillips; book 3 p. 170.

2109. 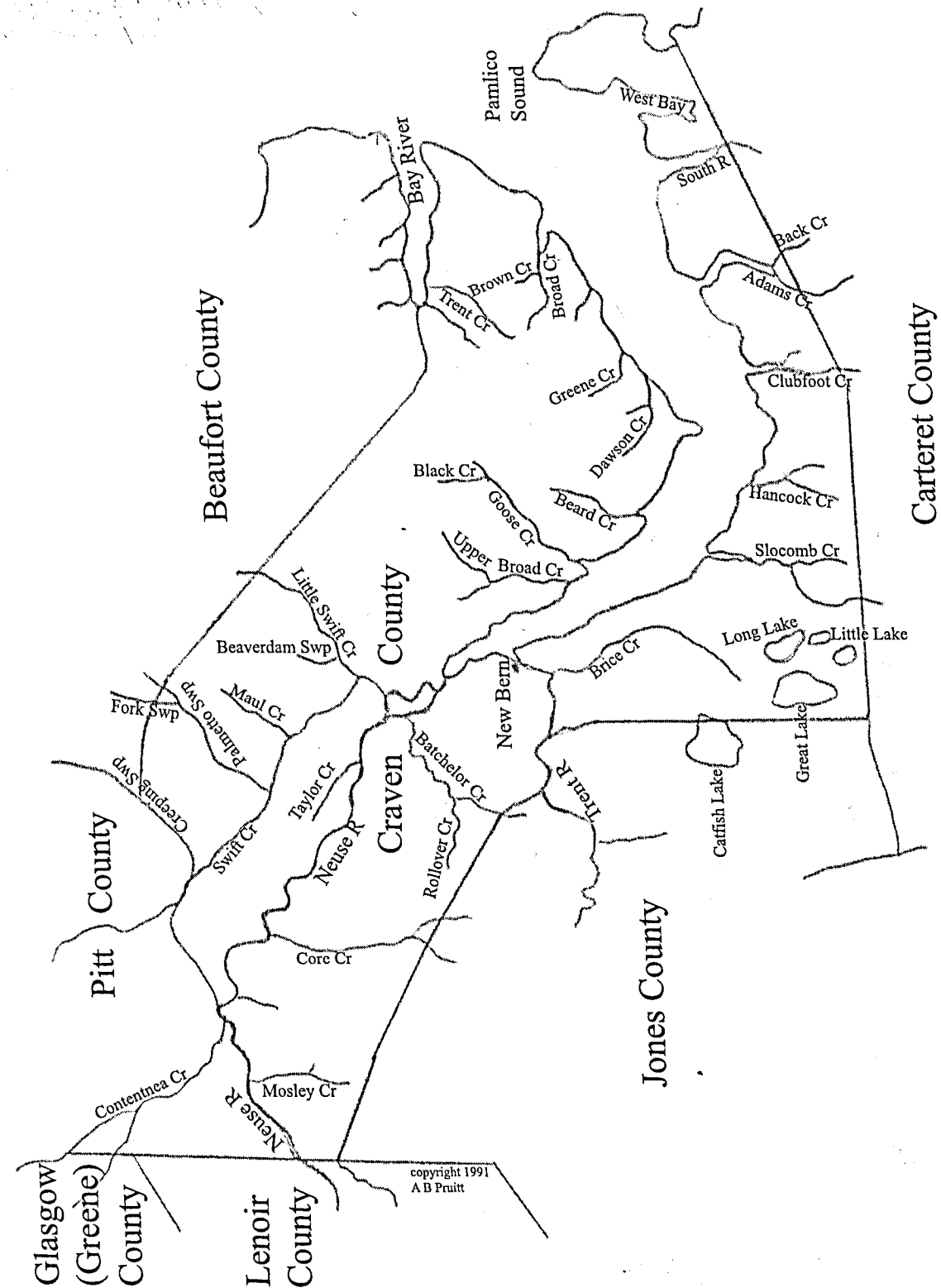

9. Next is the title chain, when given, beginning with the grant and continuing (when possible) to the grantor of the deed.
10. Following "(signed)" is the spelling or mark made by the grantor(s). Unusual marks are added by hand. Please note the "signature" in the deed book is really a copy (made by a clerk) of the original signature on the original deed. Also note: an "X" written at an angle may look like a "+" in the book; so these two marks may be the same mark.
11. Following "witness" are the names of the witnesses to the sale. The word "jurat" follows the witness who proved the deed in court; "acknowledged" indicates the grantor proved the deed in court, & "recorded" indicates the clerk didn't indicate who proved the deed.

The map which follows this introduction is included to help the reader locate the waterways mentioned most frequently in the index. The creek locations are not meant to be exact. More complete and accurate maps of the counties can be obtained from the North Carolina Department of Transportation (highway maps), Department of Water Resources (maps grouped by major river basins), a book of county maps (from Puetz place, Lyndon Station, WI), or a book of county maps (from DeLorme, Box 298-6900, Freeport, ME 04032).

The plat for the town of New Bern (in 3 parts) is from MC 195 N534 1819 p. 2 in the North Carolina archives.

This book is dedicated to the late John H Oden III who for many years assisted genealogists in the Beaufort County area with their work. Some of the fun and enjoyment of genealogical work departed with Mr. Oden. 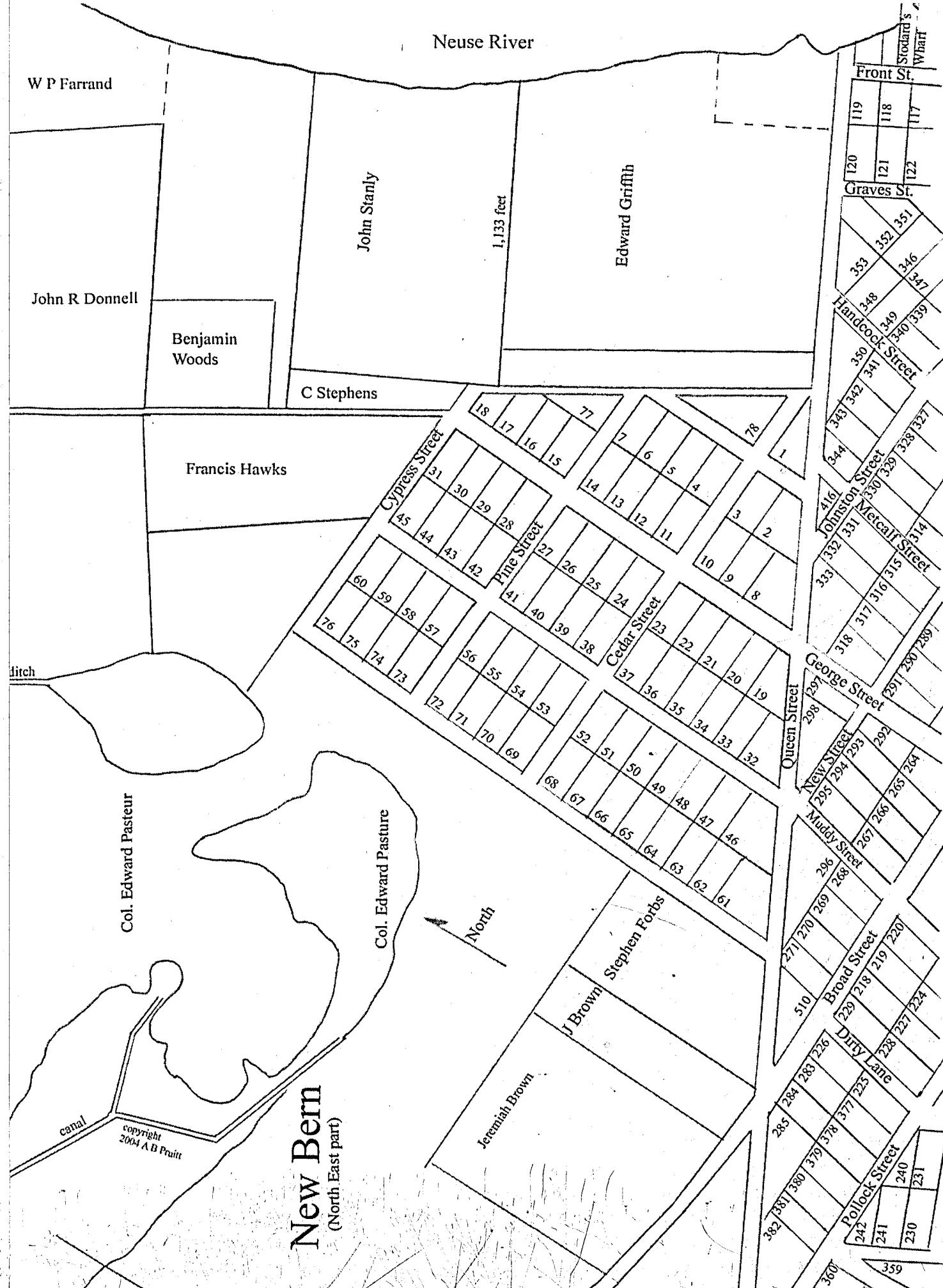
