On this first day of October A.D. one thousand Eight hundred and fifty-one (?) personally appeared before me S. Wilds Dubose a magistrate within the for the District and State aforementioned John R. Sparrow aged seventy years a resident of Chesterfield District in the State of South Carolina who being duly sworn according to Laws declares that he is the identical John R. Sparrow who was a private in the company commanded by Captain James K. Hayward & Lieut John L. (?) Smith in the Regiment of North Carolina Militia commanded by Colonel James Hatelo in the war with Great Britain declared by the United States on the 18<sup>th</sup> day of June A.D **1812** that he volunteered at Kingston North Carolina on or about the first of September A.D 1814 for the term of six months and two days and was honorably discharged at Newborn North Carolina about the fifteenth of March A.d 1815 that he has lost his certificate of discharge but the fact will appear by the Muster Rolls of said company. He marks this declaration for the purpose of obtaining the bounty land to which may be entitled under the granting bounty land to certain Officers and Soldiers who have been engaged in the Military service of the United States [illigible] September 28<sup>th</sup> 1850.

On this 23<sup>rd</sup> day of March AD 1857 Darlington District Personally appeared before me M. A. Huggins one of the magistrates in and for the District of Darlington & State aforesaid John Sparrow a resident of Darlington District & State aforesaid aged Seventy one years who being duly Sworn according to law declares that he is the identical John Sparrow who was a private in the Company Commanded by Captain (name not recorded): 1 Liutenants [sic) name John S. Smith 2<sup>nd</sup> Isaac Heller Insign John Harlow in the North Carolina Regiment commanded by Col Tisdel in the war with Great Britain declared by the United States on the 18<sup>th</sup> day of June 1812. – that He Entered Service on or about the 1 4<sup>th</sup> of September 1814 in Craven County N.C. for the term of Six months & was Stationed at Hanging Point near Newbern N.C. and continued in actual Service until regular discharged in Newbern N.C. in March 1815. He makes this declaration for the purpose of obtaining the Bounty Land to which he may be entitled under the act approved March 3<sup>rd</sup> 1855. He also declares that he has not received a warrant for Bounty land under this or any other Act of Congress nor made any other application therefor.


